Submission of Papers for Presentation

All papers should be based on research.

Selected papers will be allotted 45-minute presentation slots of which 15 minutes should be reserved for questions and discussion. It is up to the speaker to give either a short presentation (10 – 15 minutes) and use the remaining 30 minutes for discussion or give a longer presentation and leave only the minimum 15 minutes for discussion.

The preferred language for papers and presentations is English; deviations from this should be checked in advance with the conference organisers.

Technical equipment including overhead projector, beamer and laptop plus DVD and VHS equipment will be available for presentations. Please contact the local organising committee if you have specific requirements.

Within the framework of this conference on ‘**Audiovisual Translation Scenarios**’ we especially welcome papers with a focus on the following domains:

- 1) Subtitling (including live subtitling and subtitling for the deaf and hard of hearing)
- 2) Dubbing
- 3) Media Translation and Interpretation
- 4) Theory and Practice of Polysemiotic Translation
- 5) Intercultural Aspects of Media Translation

Guidelines for the Submission of Proposals for Papers:

Proposals for Papers (Short Abstracts)

Proposals for papers in short abstract form when printed out should fit on a single page of 12-point type, with margins of 2 cm (exclusive of references). They should contain the proposer's name, affiliation, postal and e-mail addresses.

Abstract proposals must be received in electronic format (MS-Word, text or rtf files) at

info@euroconferences.info

no later than **15 January 2006**.

The abstract proposals will be evaluated by members of the scientific committee and proposers will be notified by 15 February 2006 if their proposal has been accepted.

Upon acceptance of an abstract proposal, speakers will be asked to submit an extended abstract. Extended abstracts will be made available to the conference participants before the conference to facilitate interaction and discussion as was done at the Saarbrücken 2005 Conference.

Publication

Selected papers will be published.

Registration and fees

General registration deadline is 15th March 2006.

Fees: The registration fee is 400,-- €.

This fee includes:

- participation in the 5-day-conference
- conference folder
- book of extended abstract
- lunches during the conference
- refreshments during coffee breaks

Registration is only valid upon receipt of the conference fee.

Scholarships for Young Researchers
